- **Attendance** – Come to school every day, on time and in uniform.
- **Behaviour** - Behave in an appropriate way at all times.
- **Care** – Show care for all people, places and property.
- **Diversity** – Be kind: show respect and tolerance towards each other.
- **Effort** – Show positive learning behaviours, challenge yourself and always do your best.

The Parent(s)/ Carer(s) will:

- Respect all members of the school community and behave in an appropriate manner at all times while on the school site.
- Encourage your child(ren) to do their best.
- Encourage your child(ren) in their learning and offer appropriate support at home for homework and reading.
- Encourage your child(ren) to become independent and take responsibility for their actions.
- Attend parent-teacher meetings to discuss your children's learning.
- Make sure your child(ren) attend regularly, arrive and are collected on time.
- Ensure children are well prepared for learning with adequate sleep and breakfast.
- Make sure you inform the school of any absence on the day by telephone and on any subsequent day and providing evidence for absence.
- Make sure that your child(ren) is/are dressed appropriately and in full uniform with necessary kit.
- Ensure photographs taken are only of your child(ren), are only taken where/when appropriate (e.g. at a concert) and that they are not posted onto social media sites.
- Inform the school of anything that you feel may be affecting your child's learning and behaviour.
- Share any concerns you have by talking to a member of staff.
- Support the school's expectations of good behaviour.
- Understand that no holidays can be taken during term time.
- Follow policies of the school (found on the school website or available on request from office).
